ARTICLES OF INCORPORATION

1. Name. The name of the corporation is Smokey's, Inc..
2. Authorized shares. The aggregate number of shares the corporation is authorized to issue shall be 3,000, all of which shall be common voting stock.
3. Registered office and agent. The registered office of the corporation is 2228 Main Street, Boise, Id 83702 and its registered agent at that address is Mike Bejarano.
4. Incorporator. The name of the incorporator is Mike Bejarano and the incorporator's address is 2228 Main Street, Boise, ID 83702.
5. Mailing address of corporation. The mailing address of the corporation is 2228 Main, Boise, ID 83702.
6. Voting Entitlement of Shares. (1) Except as provided in sections (2) and (4) of this Article, each outstanding share, regardless of class, is entitled to one (1) vote on each matter voted on at a shareholders' meeting. Only shares are entitled to vote.
(2) This corporation is not entitled to vote treasury shares. The shares of this corporation are not entitled to vote if they are owned, directly or indirectly, by a second corporation, domestic or foreign, and this corporation owns, directly or indirectly, a majority of the shares entitled to vote for directors of the second corporation.
(3) Section (2) of this Article does not limit the power of this corporation to vote any share, including its own shares, held by it in a fiduciary capacity.
(4) Redeemable shares are not entitled to vote after notice of redemption is
