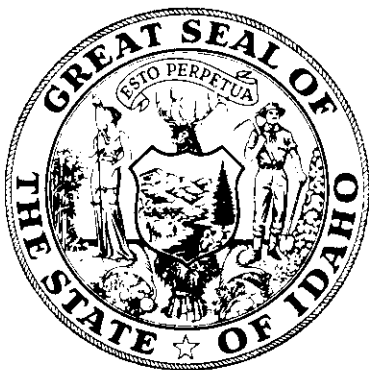

## ARTICLES OF DISSOLUTION

To the Secretary of State of Idaho:

Pursuant to the divisions of section 30-1-92 of the Idaho Business Corporation Act, the undersigned corporation adopts the following articles of dissolution for the puposes of dissolving the corporation:
