

KNOW ALL MEN BY THESE PRESENTS:- That , we, the undersigned, the duly elected , qualified and acting Directors and Secretary , Minister, and Members of the Church of the Nazarene, of Moscow , in Latah County , State of Idaho, and as Christians, have this day associated ourselves together, both as individuals and as representatives of the member of the Church of the Nazarene, of Moscow , Idaho, for the purposes of forming a religious corporation under the laws of the State of Idaho;

And We Do Hereby Certify:

FIRST ; That the name of the corporation shall be and is " CHURCH OF THE NAZARENE", of Moscow , Idaho.

SECOND:- That the purposes for which it is formed are ; (A) To carry on , teach, advance, conduct, promulgate and promote the religion and religious belief's, Laws, principals and doctrines of the Church of the Nazarene, within the state of Idaho, and at any other place or places that may hereafter be considered meet and proper, in harmony with the Word of God to its fullest extent in accordance with the rules, regulations, discipline and teachings of said Church;

(B) To transact and carry on all kinds of business'es ancillary, related, pertaining necessary or proper to , or connected with, the purposes or uses for which this corporation is formed;

(C) To purchase, acquire, receive, own, lease, hold, develop, improve, manage, take, alienate, mortgage or convey real estate or personal property, for the business or objects of the association, and that may be found necessary in connection therewith ; To, by , and through its Board of Directors, create obligations or indebtedness for and on behalf of such corporation for the uses , benefit's and business of such corporation, and to evidence such obligations or indebtedness, by the issuance of promissory notes, or note, due bill, Bonds or other evidence's of such indebtedness of the corporation,

and to by , and through its Board of Directors, secure the payment of the same by real or chattle mortgages or mortgage on the property of the corporation;

(D) That pecuniary proffits are not the object of this corporation, and there shall be no Capital Stock thereof.

THIRD :- That the place where its principal place of business is to be transacted, shall be at Moscow ,in Latah County , State of Idaho.

FOURTH:- That the term for which it is to exist is fifty (50) ,years from and after the date of its incorporation.

FIFTH:-That the number of its Directors shall be Three (3) and the names and residences of those who are elected for the first year are --

SIXTH:-- That after the first year one third of the members of its Directors shall be elected for a term of one year, and one third thereof for a term of two years, and one third thereof for a term of three years, and thereafter and at each succeeding annual election or meeting of the members ,one third of such directors shall be elected for a term of three years.

SEVENTH:- We hereby certify that on the 7th day of August A.D. 1920, between the hours of eight o'clock P.M. and nine o'clock P.M. of said last mentioned date, at the Church house of the Church of the Nazarene, of Moscow ,Idaho, situated on the corner of Third and Howard Streets in the City of Moscow ,Idaho, there was held a general election by the members of said Church of the Nazarene, of Moscow ,Idaho, for the election of three Directors for said Church for the ensuing

year in pursuance with the provisions of Section's 4870 and 4871 of the Idaho Compiled Statutes of A.D. 1919 ; That at such time and place, and at such election there were 19 members of said church and association present and voted; That upon said election polls being closed at the hour of 9.19 O'clock P.M. of said 7th day of August A.D. 1920, the votes cast were by the said Judges of Election counted, and the Clerk of the said Election and recorded, whereupon and wherefrom it was shown that E.S. Wilson received 17 votes for Director of said church for the said ensuing year ; That John E Hall received 11 votes for Director of said Church for the ensuing year ; That W.S. Bellamy received 16 votes for Director of said church for the ensuing year ; That Mrs O.D. Chism received 10 votes for Director of said Church for the ensuing year, and that Mrs *Ina* Jack received 7 votes for Director of said church for the ensuing year ; That thereupon members E.S. Wilson , John E Hall and W.S. Bellamy were declared the duly elected Directors of the said Church of the Nazarens , of Moscow , Idaho, for the ensuing year.

That before said election of Directors was so held written notice of the time and place of the holding of such election was given by publication for two weeks in the Weekly " Idaho - Post", a newspaper of general circulation published weekly in Moscow , Idaho (said notice being published for three successive times in said " Idaho -Post") the first publication of said notice being on the 23rd day of July A.D. 1920 and the last publication thereof being on the 6th day of ~~August~~ *August* A.D. 1920; and

That a copy of said notice giving the time and place and notice of such election was also posted on the front door of the said Church building wherein such election was held, for the length of time that the same was so published;

All of which more particularly appears from the verified report of the facts surrounding such election, of the Judges and Clerk of such election, the verified proof of publication of such notice of election; the verified report and proof of the posting

of the notice of such election, and the original notice of election, all of which are hereunto attached, marked "Exhibits A, B, C. & D" respectively and made a part hereof.

That at the time and place of holding such election and before the members proceeded to vote thereat, members Mr Nellie Hunt & Mr Glenn Higgins were by the members present, elected Judges of such election, and member Mr A. D. Chism was elected Secretary of Election, and that such officers thereafter conducted said election, as such Judges and Secretary thereof.
