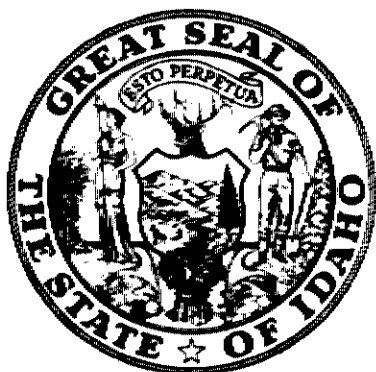


FIRST

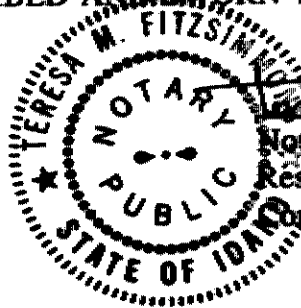
