That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation, under and by virtue of the Laws of the State of Idaho.

AND WE HEREBY CERTIFY,-

FIRST,- That the name of this Corporation shall be "The Clements & Spori Ditch Company, a Corporation Limited".

SECOND,- That the purposes for which this Corporation is formed are,- To Hold, Contract, Buy, Sell Or Dispose of Water and Water Right and Ditches for Agricultural, Manufacturing and Culinary; To Hold, Buy and Sell Real Estate for the proper Distribution and Manipulation of Water Ditches and Offices of said Company.

THIRD,- That the principal place of said Corporation shall be Hibbard, Fremont County, Idaho.

FOURTH,- That the term for which said Corporation shall exist is Fifty Years, from and after the date of Incorporation.


