# ARTICLES OF INCORPORATION

of the

Sagle Baptist Church,

of - Sagle, Idaho

ARTICLE FIRST : The name of this corporation is the Sagle Baptist Church of Sagle, Idaho. And this corporation is organized pursuant to the General Non-profit Corporation Law, Title 30 - Chapter 3 - Idaho Code.

ARTICLE SECOND : The office for the transaction of the business of said corporation shall be located in the city of Sagle, County of Bonner, State of Idaho.

ARTICLE THIRD : The existence of the Sagle Baptist Church, Inc., of Sagle, Idaho, is a perpetual corporation.

ARTICLE FOURTH : The purpose for which this corporation is organized shall be:

(a) The primary purpose for which the corporation is organized is to promote religious, moral, educational missionary and evangelistic work, in accordance with the practice of a Regular Baptist Church.

(b) To acquire, purchase, lease and encumber the necessary real property to be used in connection with the objects of this corporation, and to erect necessary buildings thereon, and to do the things requisite or desirable to carry out the objects of said corporation.

(c) To receive, own, and dispose of cash and securities to be used from time to time for the development of interests of this corporation.

(d) To have a common seal and alter the same at pleasure, and to take into possession and custody all the temporalities of the church, and to make the rules and regulations for the management thereof, whether the same shall consist of real or personal estate, and whether the same shall have been given, granted or bequeathed or devised directly or indirectly to said church or to any person for its use.

(e) To bargain, sell, convey, mortgage or release any real estate belonging to said church or held by them as trustees, and to erect churches, parsonages, school houses, and other buildings for the direct and legitimate use of said church, and to alter and repair the same, and to fix the salary of its minister or ministers (if at any time there be more than one) or to anyone in its employ.

(f) To do each and everything necessary, suitable and proper for the accomplishment of any one or more of the purposes hereinbefore enumerated or conducive to or expedient for the interests or benefits of the corporation.

The foregoing statement of purposes shall be construed as both a statement of purposes and powers and the purposes and powers stated in each clause, except where otherwise expressed, are in no wise limited or restricted by reference to or inference from the terms and provisions of any other clause, but shall be regarded as an independent purpose, and all for the primary object of carrying out the purposes and principles of the Baptist Faith.

ARTICLE FIFTH : The trustees of the Sagle Baptist Church shall have sole care, custody and control of all properties. They shall be the only ones to sign purchase agreements, sale contracts and other legal documents when requested to do so by votes of the congregation.

ARTICLE SIXTH : The Articles of Incorporation or By-Laws adopted in conformity herewith may be amended by the adoption of a resolution by the Board of Directors or Trustees, and the vote or written assent of a unanimous vote of the members entitled to vote.

ARTICLE SEVENTH : That the number of trustees or directors of said corporation shall be three or more, and the names and residences of said trustees or directors who have been elected for the first year, and to serve until the election and qualification of their successors in office, are as follows, to wit: The designated registered agent is Ray Hatcher, Jr. *Sagle, Idaho*

ARTICLE EIGHT : That it is a corporation which is not formed for pecuniary gain and does not contemplate pecuniary gain or profit to the members thereof, and no revenue received or derived from the activity or operation of the corporation is inure to the benefit of any individual.

ARTICLE NINTH : The property is irrevocably dedicated to religious, charitable, scientific or hospitable purposes and upon the liquidation, dissolution or abandonment of the owner will not inure to the benefit of any private person except a fund, foundation or corporation organized and operated for religious, hospital, scientific or charitable purposes.

ARTICLE TENTH : If at any time the Sagle Baptist Church would cease to function and dissolve; all monies and property shall belong to the Northwest "Regular Baptist Home Mission" whose present address is Box 308, Everson, Washington. 98347.
