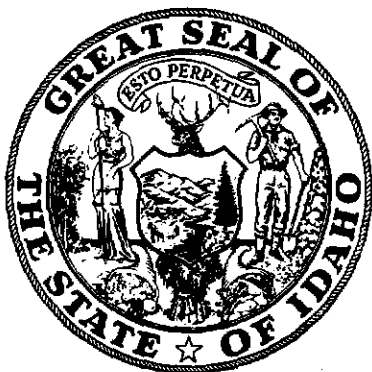



That there were no creditors and are no creditors of the said corporation, and, therefore, there is no notice to be given to any creditor of the prospective dissolution as provided for in Section 30-187 of the Idaho Code.

That all actual debts, obligations and liabilities of the corporation have been paid and discharged.


