ARTICLES OF INCORPORATION OF
CAMAS PRAIRIE INSURANCE, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation: 2

FIRST: The name of the corporation is CAMAS PRAIRIE INSURANCE, INC..

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1000 shares of one class of common stock. The par value of said stock shall be \$1,000.00 per share.
