ARTICLES OF INCORPORATION OF
CAMAS PRAIRIE INSURANCE, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is CAMAS PRAIRIE INSURANCE, INC..

SECOND: The period of its duration is perpetual.

9 THIRD: The purpose or purposes for which the corporation is
10 organized are: the transaction of any or all lawful business for
11 which corporations may be incorporated under the Idaho Business
12 Corporation Act.

13 FOURTH: The aggregate number of shares which the corporation
14 shall have authority to issue is 1000 shares of one class of common
15 stock. The par value of said stock shall be \$1,000.00 per share.

27 elected and shall qualify are:


