
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act (Idaho Code §30-1-1 et seq) adopt the following Articles of Incorporation for such corporation:

I. NAME

The name of the corporation is IDAHO ELECTRIC, INCORPORATED.

II. DURATION

The period of its duration is perpetual.

III. PURPOSES

The purposes for which this corporation is organized is to do electrical contracting and repair; and to transact any other lawful business for which corporations may be incorporated under this act.

IV. STOCK

The aggregate number of shares which this corporation shall have the authority to issue is ONE HUNDRED THOUSAND (100,000) shares common voting stock at \$10.00 per share par value.

V. PRINCIPAL PLACE OF BUSINESS
AND REGISTERED AGENT
