KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, MIREN E. ARTIACH, JOSE M. ARTIACH, and EVERETT T. WOHLERS, all of Boise, Ada County, State of Idaho, two-thirds (2/3) of whom are citizens of the United States of America, and each and all the age of majority, do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt and execute the following Articles of Incorporation, and do hereby certify and declare:

I

That the said corporation is and shall be "ARTIACH TRUCKING, INC."

II

That the said corporation is formed for the following purposes:

(a) To engage in the transport of agricultural products as authorized by the authority granted by the Idaho Public Utilities Commission and to do all things connected therewith and incidental to.

(b) To exercise all authority and to perform all acts authorized under the provisions of Section 30-114 of the Idaho Code.
