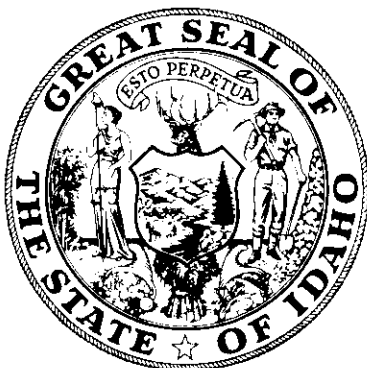

Know all men by these presents:

That the undersigned being a natural person of full age and a citizen of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, does hereby certify as follows:

Article I The name of the corporation shall be Universal Designs, Inc.

Article II This corporation shall be perpetual in existence.

Article III The purposes for which said Corporation is formed are, to the extent permitted by the Corporation Act of the State of Idaho: To have, exercise and enjoy all of the powers now or hereafter granted to a corporation organized under the laws of the State of Idaho.

Article IV The amount of capital stock of this corporation shall be 50,000 shares of no par value. All of the shares of stock of the corporation shall be common, nonpreferred stock and all of the shares shall be entitled to vote.

Article V The location and post office address of the corporation's registered office shall be 2309 Mountain View Drive, Boise, Idaho 83706 and the registered agent shall be Jake W. Peterson, whose address is 2309 Mountain View Drive, Boise, Idaho 83706.

Article VI The Board of Directors shall consist of at least three directors, but during the term of office, or thereafter, the number of directors may be increased or decreased from time to time as may be provided by the By-laws. The Board of Directors who shall serve until their successors shall have been elected and qualified are:

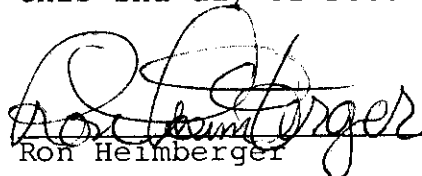
