

ARTICLES OF INCORPORATION

WE, THE UNDERSIGNED, being residents of the state of Idaho, desire to associate ourselves into a corporation under and by virtue of the laws of the state of Idaho, for the following reasons and purposes:

I.

The name of this corporation shall be "THE SAWTOOTH GRAZING ASSOCIATION."

II.

The purpose for which this corporation is formed is to take all steps as may appear necessary for the protection of the sheep industry with grazing rights in the National Sawtooth Forest and on Government lands adjacent thereto, by leasing State and Government lands in such forest reserve and State and Government lands adjacent thereto.

III.

The principal place of business of this corporation shall be in the village of Shoshone, Lincoln County, State of Idaho.

IV.

The term for which it shall exist shall be fifty (50) years.

V.

The number of directors shall be nine (9).

VI.

The amount of capital stock shall be Fifty Thousand (\$50,000.00) Dollars divided into 100,000 shares of Fifty (50¢)

Cents each, to be subscribed to the capital stock in the proportion of one share to every Five Hundred (500) sheep or major fraction thereof, by the stockholders of this corporation.

VII.
