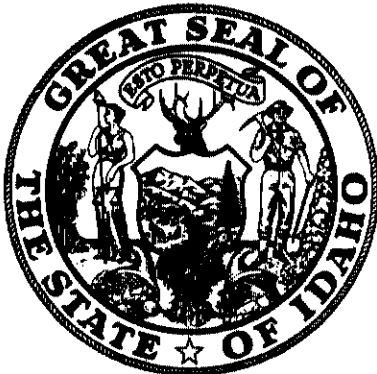
### CERTIFICATE OF INCORPORATION OF

**ARTICLES OF INCORPORATION  
SPRAYMASTER NORTH AMERICA, INC.**

In order to organize a corporation for profit under the Idaho Business Corporation Act, the undersigned, a natural person of adult age and a citizen of the United States, hereby adopts the following ARTICLES OF INCORPORATION.

1. The name of the corporation is SPRAYMASTER NORTH AMERICA, INC.

2. The period of its duration is perpetual.

3. The purpose of the corporation is to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

4. The corporation is authorized to issue up to One Thousand (1,000) shares of capital stock, all of one class, of no stated par value.

5. The internal affairs of the corporation shall be governed by Bylaws adopted by at least a majority vote of the Board of Directors.

6. Transfer of shares shall be restricted by a requirement that before any shares can be transferred they must first be offered for sale to the corporation and other shareholders, as more fully set forth in the Bylaws.

7. The address of the initial registered office of the corporation is 305½ Pine Street, P.O. Box 621, Bovill, Idaho 83806-0621. The name of its initial registered agent at that

address is Gerald G. White.

8. The number of directors of the corporation shall be as specified in the Bylaws, and such number may from time to time be increased or decreased in such manner as may be prescribed in the Bylaws. The initial Board of Directors shall consist of two directors, whose names and addresses are set forth below and who shall serve until their successors are elected at a duly constituted meeting of shareholders: Garrie Thomas John, 40 Monyash Road, Carine, Perth, West Australia 6020; Dinko Zanetic-Mijo, 40 Monyash Road, Carine, Perth, West Australia 6020.

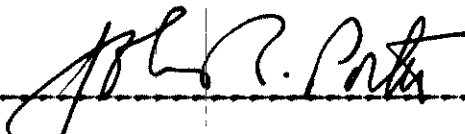
