## CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION.OF

## THE IDAHO BAPTIST CONVENTION OF THE STATE OF IDAHO

We, the undersigned Author F. Colver and W.F.R. Hartley, Chairman and Secretary, respectively of that certain meeting of The Idaho Baptist Convention of the State of Idaho held at the First Baptist Church, Pocatello, Idaho, on the 12-14 day of October, 1926, as hereinafter described, do hereby certify that the Articles of Incorporation of the said Corporation were amended as hereinafter set forth and the that the following proceedings have been had in connection therewith, to-wit:

- That the regular Annual Meeting of said corporation at which the Articles of Incorporation of said corporation were amended was announced thirty days prior to said meeting in the Idaho Baptist Messenger the official monthly publication of said corporation.
- 2. That notice of intention to amend articles of incorporation was published in the Ideho Baptist Messenger thirty days prior to said annual meeting.
- 3. That notice of intention to amend articles of incorporation was published in The Idaho Pioneer and the New Freedom published weekly at Boise, Idahok for five consecutive weeks the first publication being on the 10th day of September, 1926 and the last publication being on the 8th day of October, 1926.
- That pursuant to the proceedings hereinbefore set forth and / on the 13th day of October, 1926 The Idaho Baptist Convention of the State of Idaho met in regular annual session at the First Baptist Church, Pocatello, Idaho, as above set forth, at which meeting the following resolution was thereupon moved, seconded and carried:

"Resolved, That this Convention amend Section Two of the Articles of Incorporation of The Idaho Baptist Convention of the State of Idaho to include the following provision:

"'To receive gifts and bequests of property, both real and personal, which may be tendered to said Convention for the promotion of its objects and purposes; to become the depository of funds or per-

to make contingent gifts or bequests to said Convention and to convert any gifts or bequests into cash and to loan or invest the principal or the proceeds thereof in income property or securities; to act as trustee; to enter into contract with persons, firms or corporations for the payment of annuity in the manner now generally recognized as the annuity or endowment plan, but in no case for pecuniary profit.\*\*

That upon the question of the above resolution the vote was unanimous and that the chairman of said meeting thereupon declared the motion unanimously carried and adopted.
