a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **First** day of **November** 19**66**, original articles of amendment, as provided by Section **30-146, 30-147 and 30-150, Idaho Code**, extending corporate existence for a term of 50 years,

WHEREAS, the First Methodist Episcopal Church of Richfield, Idaho, was duly incorporated on the 20th day of July, 1909, as a domestic corporation of the State of Idaho, and,

WHEREAS, it has become necessary for said church to renew its corporate existence, and

WHEREAS, the Board of Trustees of the Richfield Methodist Church did, on the 5th day of June, 1966, call for a meeting of the members of said church and corporation, to be held on the 27th day of June, 1966, at the hour of 8:00 o'clock, P.M., to determine whether the corporate existence of the Richfield Methodist Church should be extended for a further term of fifty years, and

WHEREAS, said Notice of Meeting was published in the Lincoln County Journal on June 9, 1966, June 16, 1966, and June 23, 1966, and

WHEREAS, at said meeting held at 8:00 o'clock, P.M., in the Richfield Methodist Church, on June 27, 1966, more than two-thirds of the members present at said meeting did vote to extend the term of the corporate existence of said church for a further term of fifty years,

NOW, THEREFORE, it is hereby determined by the membership of the Richfield Methodist Church that the corporate existence of said church and corporation be extended for a further term of fifty years.
