

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned natural persons of lawful age and citizens of the United States, for the purpose of forming a corporation pursuant to the provisions of the Idaho Non-profit Corporation Act (Title 30, Chapter 3, Idaho Code), Do hereby certify as follows:

FIRST

The name of the corporation is Kootenai County Centennial Committee, Incorporated.

SECOND

The corporation is a nonprofit corporation.

THIRD

The duration of the corporation shall be through fiscal year 1991. Corporation terminates June 30, 1991.

FOURTH

The Kootenai County Centennial Committee was formed to provide a local organizational focus for Idaho Centennial activities in Kootenai County. The purposes for which the corporation is organized include the transaction of all lawful business for which corporations may be incorporated under the Idaho Nonprofit Corporation Act (Title 30, Chapter 3, Idaho Code).

FIFTH

The corporation will be comprised of members with elected directors who shall be responsible for the management of its affairs pursuant to Section 30-314(c), Idaho Code.

SIXTH


