# ARTICLES OF INCORPORATION OF VALLEY ECONOMIC RESOURCE CENTER, INTORPORATED

8 45 AH 183

The name of the corporation is the Valley Economia Resource Center, Incorporated.

#### ARTICLE II - NONPROFIT STATUS

The corporation formed herein is a nonprofit corporation.

### ARTICLE III - DURATION

The duration of this corporation shall be perpetual.

### ARTICLE IV - MEMBERS

The corporation shall have no members and its initial Board of Directors shall be approved by the Lewis Clark Economic Development Corporation.

#### ARTICLE V - PURPOSE

The purpose or purposes for which the corporation is organized are as follows:

- The purpose of this corporation shall be to engage in any lawful activity authorized by Title 30, Chapter 1 and Chapter 3 of the Laws of the State of Idaho and by Chapter 24.03 of the Revised Code of Washington.
- To provide information for and to promote and assist the growth and development of the economy of the Lewis-Clark Valley.
- To enter into, make and perform contracts of every kind or description;
- To borrow or raise monies for any other purposes of the corporation and from time to time without limit as to amount, to draw, make, accept, endorse, execute and issue promissory notes, drafts, bills of exchange, warrants, bonds, debentures, and other negotiable or non-negotiable instruments and evidences of indebtedness and to secure the payments of any thereof and of the interest thereon by mortgage upon or pledge, conveyance or assignment in trust of the whole of any part of the property of the corporation whether at the time owned or thereafter acquired and to sell,
