The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I: The name of the corporation is **IDAHO INK, INC.**

ARTICLE II: The purposes of the corporation are to print, bind, publish, circulate, distribute, buy, sell and deal in books, pamphlets, circulars, posters, newspapers, magazines, literature, music, pictures, tickets, cards, advertisements, letter and bill heads, envelopes, and legal, commercial, and financial forms and blanks of every kind. To carry on a general printing, engraving, lithographing, electrotyping, and publishing business in all branches thereof.

ARTICLE III: The period of duration of the corporation is perpetual.

ARTICLE IV: The address of the corporation's initial registered office in the State of Idaho is 823 Main Street, Sandpoint, Idaho 83864, and the name of its initial registered agent at such address is Terry Lee Crousore.

ARTICLE V: The aggregate number of shares which the corporation shall have authority to issue is Twenty Thousand (20,000). The total authorized number of shares shall be without

par value. The corporation is authorized to issue only one class of stock. Stock shall be issued and transferable only to natural persons who are not non-resident aliens.

ARTICLE VI: The number of directors constituting the initial board of directors is One (1) and the name and address of the person who is to serve as director until the first annual meeting of the shareholders or until his successor is elected and qualified is:
