ARTICLES OF INCORPORATION OF THE IDAHO BEEKEEPERS ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have associated ourselves together, and do hereby under and pursuant to the laws of the State of Idaho, associate ourselves together, forming a non-profit cooperative association and hereby adopt the following as articles of incorporation under which said corporation shall operate:

Article 1. The name of this corporation shall be Idaho
Beekeepers Association, Inc.

Articles 2. The purpose and powers of this corporation shall be:

- (a) To promote further education and understanding of the members of the association in the buying, selling, and culture of bees, and the purchase, production and sale of honey and the manufacture and sale of food products and the further utilization of honey in products;
- (b) To promote, encourage and foster the passage of legislation in the interests of the members and the public in connectionwith the bee and honey industry;
- (c) To promote the consumption of honey and to conduct advertising campaigns in connection therewith;
- (d) To acquire by purchase or otherwise land and personal property as may be necessary and proper to effect the desired aim and goals of the association and to do all things necessary and proper in connection therewith;
- (e) To borrow money for the accomplishment of the above purposes and to execute notes and mortgages in connection therewith;

Article 3. The location and post office address of its registered office is in the City of Gooding, County of Gooding, State of Idaho.

Article 4. The term for which said corporation is to exist is perpetual.

Article 5. The number of directors shall be six;

Article 6. The corporation is not organized for pecuniary profit nor shall it have any power to issue capital stock or declare dividends and no part of its earnings shall inure to the benefit of any member, director or individual. The association shall issue membership certificates to each member thereof which certificates cannot be assigned so that the transferee thereof can by such transfer become a member of the association except by resolution of the Board of Directors and under such regulations as the by-laws may prescribe. The rights and interests of all members shall be equal and no member can have or acquire a greater interest therein than any other member;

Article 7. Future members may be admitted as a member of the association upon the terms and conditions provided by the by-laws and upon the payment of dues as provided by said by-laws.

Article 8. Directors shall be allowed and shall hold office as provided by the by-laws;

Article 9. The corporation shall not have a seal;
