

ARTICLES OF INCORPORATION.

The undersigned, desirous of forming an incorporation, do hereby agree and declare as follows:

1. The name of the corporation shall be, Advance Mining Company.

2. The purpose for which said corporation is formed is the purchase and acquisition of mines, mining claims, real estate, water rights, millsites, tunnel sites and other easements, mining ores, milling, concentrating and reducing the same buying and selling ore and bullion with power to conduct mercantile business, boarding-houses, hotels and other adjuncts to mines and concentrating mills, and generally to do and transact mining, milling and concentrating business with all powers incident thereto.

3. The principal place of business of this corporation shall be at Wallace, Shoshone County, State of Idaho, with power to establish branch offices elsewhere in Idaho.

4. The term for which this corporation is to exist is fifty (50) years.

5. The number of its directors shall be five. The names and residences of those appointed for the first year are as follows:-

6. The amount of capital stock is fixed at one Million dollars (\$1,000,000) divided into one million shares of the

par value of one dollar (\$1.00) each.

8. The said corporation is formed upon the basis of the conveyance to it by the owners of the following named mining claims, situate in Hunter Mining District, Shoshone County, State of Idaho, to-wit:

Dewey, Mullan, Osburn, N.P. and Shaver. And each of first two named subscribers, John Kammerer and Patrick Roddy, each hereby agree to donate and do^{as} hereby donate two hundred thousand (200,000) shares of the stock by him subscribed to the corporation, to be known as treasury stock, to be sold under the order of the Board of Directors for the purpose of working and developing the said mining properties.


