The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Marcus Koll Subdivision Water Users, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is to manage the common well of the shareholders and such related transactions and other activities as are lawful for corporations incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares, all of which are to be without par value.

FIFTH: The corporation shall have the power to make stock assessments against all issued shares. The shares shall be appurtenant to the land and upon a shareholder's failure to pay the assessment, the corporation shall have the right to make the assessment a lien against the shareholder's land.
