ARTICLES OF INCORPORATION

OF

VAGUUM POWER COMPONENTS, INC.

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, V. J. WEST, ABNER M. INGEBRETSON and D. H. CAMP, all of whom are of legal age and citizens of the United States, have this day voluntarily associated ourselves and do hereby and by these Articles of Incorporation, unite and associate ourselves for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby acknowledge, enter into, and adopt the following Articles of Incorporation.

ARTICLE I.

The name of this corporation shall be VACUUM POWER COMPONENTS, INC.

ARTICLE II.

The period of the duration of this corporation shall be perpetual.

ARTICLE III.

The principal place of business of this corporation is Coeur d'Alene, Kootenai County, Idaho, and the Post Office address of its registered office in the State of Idaho shall be 1701 North Fourth Street, Coeur d'Alene, Idaho.

ARTICLE IV.

In furtherance, and not in limitation of the general powers conferred by the laws of the State of Idaho, this corporation shall have the following purposes and powers:

- 1. To develop, acquire and promote all types of patents.
- 2. To improve, develop, prosecute and perfect

the art and business of applying electronic principals and vacuum products to practical uses; to engage in research and experimental work; to manufacture, buy, sell, trade in, lease, import, export and generally deal in electronic parts, equipment, devises and apparatus of every nature whatsoever; and to conduct the business of rendering service in the installation, operation, rental, supply of parts, repair, maintenance and upkeep of such apparatus, devises or equipment.

- 3. To engage in research for the discovery of new marketable products and to apply for and # obtain patents therefor.
- 4. To manufacture and sell, either wholesale or retail, all types of goods, wares and merchandise, either under such patents as may be acquired or under licenses or contracts from individuals, partnerships or corporations or such other goods, wares and merchandise as it may be to the advantage of the corporation to manufacture and sell.
- 5. To prospect for, and discover, and process all types of raw materials, the sources of and uses therefor.
- 6. To make and enter into all kinds of contracts, agreements and obligations by and with any person or persons, corporation or corporations, or partnerships for the purpose of acquiring, selling and otherwise disposing of goods, wares and merchandise.
- 7. To lease, rent, own, encumber or mortgage real property for the accomplishment of these purposes.
- 8. To draw, accept, endorse, acquire and sell negotiable or transferrable instruments.
- To make and enter into all kinds of contracts, agreements and obligations by and with any person or persons, partnerships, corporation or corporations for the purpose of carrying on such business.
- 10. To exercise full power to perform any and all actions connected or arising from or incidental to, and all acts proper or necessary for the purpose of carrying on such business.
- 11. To buy, sell or otherwise deal in shares of stock of this corporation and any other corporation.

ARTICLE V.

The total capital stock of this corporation is Five Hundred Thousand (\$500,000.00) Dollars consisting of Five Hundred Thousand (500,000) shares of common stock of the par value of One (\$1.00) Dollars per share. There shall be only one (1) class of stock, common stock, and each share of stock shall be equal and non-assessable.

Any and all of the stockholders of this corporation may from time to time enter into such agreements as may seem expedient to them relating to the shares of stock held by them, and limiting the transferability thereof; and thereafter any transfer of said shares shall be made in accordance with the terms of said agreement, provided that before the actual transfer of said shares on the books of the corporation, written notice of such agreement shall be given to the corporation by filing a copy thereof with the secretary and a reference of such agreement shall be stamped, written, or printed upon the certificate representing the shares, and the by-laws of this corporation shall likewise include proper provisions for the making of such agreements as aforesaid.
