On Saturday, the 8th day of July 1995, the Executive Committee of the aforesaid corporation met in Gooding, Idaho at 1:00 P.M. o'clock for the purpose of ammending the Articles of Corporation to include a non-profit purpose and a reversionary clause as part of the Articles of Corporation.

It was duly moved by Clyde Davis that the following article be included as an amendment to the Articles of Incorporation.

ARTICLE ONE

NON PROFIT PURPOSE

- A) This corporation is organized exclusively for operating a fraternal lodge for social, benevolent, and charitable purposes within the meaning of Section 501 (c) (8) of the Internal Revenue Code. Notwithstanding any other provisions of these articles, the Corporation shall not carry out any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (8) of the Internal Revenue Code. No part of the corporate assets, income or profit shall be distributable to, or inure to the benefit of its officers, trustees or members except to the extent permitted for a non profit organization under the non profit corporation laws of the State of Idaho and under the Section 501 (c) (8) of the Internal Revenue Code. The Corporation shall not take steps which serve to facilitate the transaction of specific business by its officers, trustee or member; or engage in any activity which would constitute a regular business of a kind ordinarily carried on for profit.
- B) The Sovereign Grand Lodge of the Independent Order of Odd Fellows, shall maintain a reversionary interest in this corporation such that if this corporation is dissolved, any assests of this corporation shall revert to the Sovereign Grand Lodge. Further, this corporation shall be subject to the laws, rules and regulations of the Sovereign Grand Lodge.
