ARTICLES OF INCORPORATION  
OF

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, Glenn A. Button, James G. Button, Lloyd R. Lawrence, and L. P. Shane Lawrence, all residents of the State of Idaho, and each and all citizens of the United States of America, of the age of majority, do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt and execute the following Articles of Incorporation, and do hereby certify and declare:

I

That the name of said corporation is and shall be

VICTORY BUILDERS, INC.

II

That said corporation is formed for the following purposes:

(a) To engage in the construction and sale of real property and to do all things connected therewith and incidented thereto.

(b) To exercise all authority and to perform all acts authorized under the provisions of Section 30 of the Idaho Code.
