ARTICLES OF AMENDMENT

OF

BICENTENNIAL HORIZONS COMMITTEE, INC.

KNOW ALL MEN BY THESE PRESENTS, THAT

WE, the undersigned Carm Spencer the President and Karrylle Curnes the Secretary respectively of the BICENTENNIAL HORIZONS COMMITTEE, INC., do hereby certify, declare and adopt the following amendments to the Articles of Incorporation the same having been duly adopted by a majority of the votes of the members of such corporation present at such meeting in person or by proxy at their corporation council meeting on the 16th day of January, 1984, at which time a quorum of such members were present and that the Articles of Incorporation of the BICENTENNIAL HORIZONS COMMITTEE, INC. are hereby amended as follows, to wit:

Article IV subparagraph f thereof he amended to add after the last word as it is presently constituted which is the word amended period by striking the period and adding a comma and then proceeding as follows, to wit:

, not withstanding however, this provision nor any other provision of these articles the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code.

and adding a new subparagraph g to the aforesaid article IV, such said subparagraph being as follows, to wit:

g. it being specifically understood that this corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.
