# AMENDED ARTICLES OF INCORPORATION

OF

RECEIVED SEC. OF STATE

SEASONS ROAD WATER ASSOCIATION, INC.

'88 MAY 6 AM 10 31

The undersigned, the initial Board of Directors of Seasons Road Water Association, Inc., adopt the following Amended Articles of Incorporation for such corporation. No members have been admitted to the corporation and a board of directors met on the 11th day of March, 1988. With all directors present the directors unanimously voted to amend the Articles of Incorporation by repealing Paragraphs THIRD through the THIRTEENTH and renaming each paragraph as Articles. Article I being the same as the FIRST paragraph, Article II being the same as the SECOND paragraph and the THIRD through THIRTEENTH paragraphs being deleted in their entirety and being replaced in their entirety by Articles III through XII, the text of which is set forth below.

# ARTICLE I

The name of the corporation is SEASONS ROAD WATER ASSOCIATION, INC.

# ARTICLE II

The duration of the corporation shall be perpetual.

# ARTICLE III

The corporation is organized solely for the purpose of delivering water to its members at cost, and shall supply water to no one except its members and to them only at cost, and only on and for the use on the real property hereinarter described. The corporation shall not sell, distribute, or lend water for profit. The properties and assets of this corporation shall be and are dedicated to nonprofitable purposes and for the mutual benefit of the water users or members herein.

For this purpose and in aid thereof, the corporation shall have the power to acquire, develop and operate a permanent water supply; to dig, bore, drill and otherwise excavate wells and tunnels; to construct, acquire and operate pumping plants, water storage and water distributing systems, to purchase, lease or otherwise acquire and to own, hold, mortgage, pledge, sell and deal in real and personal property necessary to promote and improve the water distribution system; to erect buildings and plants; to lend and borrow money; to execute mortgages, deeds of trusts and pledges of real and personal property; to levy assessments; and to do all other necessary or convenient things to accomplish the purpose of this corporation.

#### ARTICLE IV

The corporation shall consist of members who shall be limited to the owners of real property within the boundaries of the real property described herein. Management of this corporation shall be vested in the Board of Directors. Voting rights shall be proportionate to the number of parcels served by the system.

#### ARTICLE V

The corporation is prohibited from supplying water to any person not a member, and prohibited from supplying water to any property not described in the Articles of Incorporation. The actual cost of management and operation of the business of this corporation shall be met by the water rates, charges and assessments for the delivery of water to the certificate holders receiving water.

# ARTICLE VI

This corporation shall have a lien on its certificates of membership for all assessments levied thereon, and shall have a lien on its certificates of membership for all rates and charges for water furnished to the owners of such certificates of membership or the persons holding under them. The corporation shall provide for the enforcement of all such liens for failure to pay any assessments, rates, or charges, and shall not be required to transfer certificates of membership on its books, or to furnish water on account thereof, to such members or any person claiming under a certificate of membership, or to the land to which such certificates of membership may at the time be appurtenant, unless and until all assessments, rates and charges are paid, at the time and in the manner provided by these Articles, the By-Laws, and the Rules, if any, of this corporation.

#### ARTICLE VII

This corporation shall distribute water to its members for use on those certain lands described in the County of Kootenai, more particularly described as follows:

#### ARTICLE X

At least 85% of the income of this corporation must be collected from the members for the sole purposes of meeting losses and expenses.

#### ARTICLE XI

Upon dissolution of the corporation, each member shall share proportionately in the distribution of assets of the corporation. Gains from the sale of any of the depreciated assets shall be distributed to all persons who were members during the period the assets were owned by the corporation in proportion to the amount of business done by that person for the period.

#### ARTICLE XII

The method and manner of holding director's meetings and other corporate meetings, the authority and duties of each of the officers of the corporation and directors and all other matters for management or control of the corporation shall be determined by the By-Laws of the corporation and by the laws of the State of Idaho, but shall not be inconsistent with the Amended Articles of this incorporation as set forth herein,
