That we, whose names are hereunto subscribed, all of whom are bona fide residents of the State of Idaho, do under and pursuant to the General Corporation Laws of the State of Idaho, associate ourselves together for the purpose of becoming a body corporate, and do now declare these are the Articles of Incorporation of El Dorado Enterprises, a corporation.






