

ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is E.A. WILLS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the Corporation is organized is to provide satellite sales and service to area individuals and businesses together with all related activities and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 100,000 shares, with a par value of \$ 10.00 per share.

FIFTH: There are no provisions denying pre-emtive rights.

SIXTH: The internal affairs of the Corporation shall be governed by a duly adopted code of Bylaws which shall be consistent with these Articles of Incorporation and the laws of the State of Idaho.
