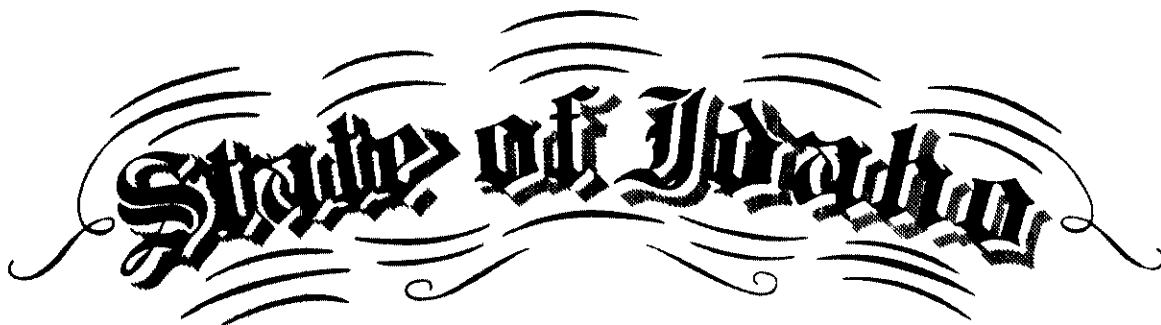

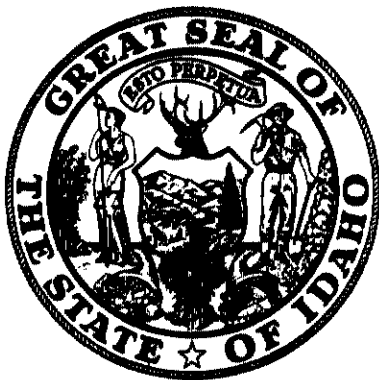
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
WOGGINS' BLOSSOM SHOPS, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age, citizens of the United States and residents of the State of Idaho, this day have voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify as follows:

ARTICLE I

The name of this corporation shall be
Woggins' Blossom Shops, Inc.

ARTICLE II

The existence of this corporation shall be perpetual.

ARTICLE III

The principal office or place of business of this corporation shall be at 3383 N. Five Mile in Ada County, Boise, Idaho 83704; but the corporation may maintain an office in such towns, cities, or places inside or outside the State of Idaho as the Board of Directors may from time to time determine, or as may be designated by the By-Laws of said corporation. The registered agent shall be Richard L. Higham, the registered office shall be at 3383 N. Five Mile, Ada County, Boise, Idaho 83704.

ARTICLE IV

The purpose for which this corporation is organized is to include the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

ARTICLE V

The total amount of capital stock of this corporation is ten thousand dollars (\$10,000.00) and the number of shares into which it is divided is ten thousand (10,000) with a par value of one dollar (\$1.00) each. Of this total capital stock, ten thousand shares (10,000) with an aggregate value of ten thousand dollars (\$10,000.00) are common stock. No preferred stock will be claimed or issued.

ARTICLE VI

The members of the governing board of this corporation shall be styled "Directors", and the Board of Directors shall consist of not less than one (1) nor more than seven (7) members, as may be provided by the By-Laws of the corporation.

ARTICLE VIII


A member of the Board of Directors of this corporation shall not be required to be a holder of any shares of capital stock of this corporation.
