## STATEMENT OF MERGER

- 3. <u>Approval</u>. The merger has been approved by the Idaho Company in accordance with the provisions of the Idaho Code, including without limitation Idaho Code § 30-22-201 et seq., and has been approved by the Nevada Company in accordance with the laws of Nevada.
- 4. Articles of Incorporation. Immediately upon the merger, the name of the Idaho Company shall be amended to be "American Pet Diner, Inc." Accordingly, the Articles of Incorporation of the Idaho Company, as in effect immediately prior to the effectiveness of the merger, shall be the Articles of Incorporation of the surviving entity except that Article I thereof is amended and restated by virtue of the merger to read in its entirety as follows:

5. <u>By-Laws</u>. The By-Laws of the Idaho Company, as in effect immediately prior to the effectiveness of the merger, shall be the By-Laws of the surviving entity except that the name of the surviving company is amended by virtue of the merger to be American Pet Diner, Inc.
