ARTICLES OF INCORPORATION
OF
NK MANAGEMENT COMPANY

The undersigned, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE ONE
NAME OF CORPORATION

The name of the corporation shall be "NK MANAGEMENT COMPANY".

ARTICLE TWO
PERIOD OF DURATION

The period of duration of the corporation shall be perpetual.

ARTICLE THREE
CORPORATE PURPOSES

The purposes for which the corporation is organized shall be any or all lawful purposes and business for which a corporation may be incorporated under the Idaho Business Corporation Act and the laws of the State of Idaho.

ARTICLE FOUR
AUTHORIZED SHARES OF STOCK

The aggregate number of shares of corporate stock which the corporation shall have authority to issue shall be One Hundred Thousand (100,000) shares. All of such shares of corporate stock shall have a par value of One Dollar (\$1.00) per share.

NO PREEMPTIVE RIGHTS

There shall be no provisions granting preemptive rights to any class of stock or any stockholder.
