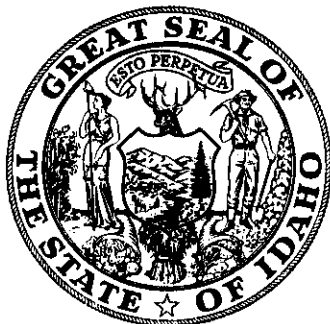

PURSUANT to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the corporation is Valley Sweeping Service, Inc.

SECOND: That the following amendment of the Articles of Incorporation were adopted by the Stockholders constituting all of the class entitled to vote thereon, pursuant to a special meeting of the stockholders of the corporation on February 28, 1994, in the manner prescribed by the Idaho Business Corporation Act.

That paragraph FIRST of the Articles of Incorporation be amended to change the name of the corporation. That this section shall thereafter read as follows:

FIRST: NAME

The name of the corporation is Venture Properties, Inc.

THIRD: The number of shares of common stock of the corporation outstanding at the time of adoption was 113 and the number of shares of common stock entitled to vote thereon was 113.

FOURTH: That the number of shares voting for said amendment was 113 and the number of shares voting against said amendment was 0.
