ARTICLES OF AMENDMENTS STATE

ARTICLES OF INCORPORATION OF

BALLET FOLK OF MOSCOW, INC.

KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, the President of BALLET FOLK OF MOSCOW, INC., an Idaho corporation, do hereby verify as follows:

That BALLET FOLK OF MOSCOW, INC. is a non-profit corporation duly organized and existing under and by virtue of the laws of the State of Idaho;

That at the Annual Meeting of the Members of BALLET FOLK OF MOSCOW, INC., held on the 1st day of May, 1982, at the hour of 10:00 o'clock a.m. of said date, at the Student Union Building, University of Idaho, Moscow, Idaho, at which said meeting a quorum of the Members of said corporation were present, a Resolution was regularly proposed, voted upon and adopted by a majority of the votes which Members present at such meeting in person or by proxy were entitled to cast, amending the Articles of said corporation, and that the following is a full, true and correct copy of the Resolution of said Members amending the Articles of said corporation, to-wit:

" RESOLUTION

BE IT RESOLVED, That the Articles of Incorporation of BALLET FOLK OF MOSCOW, INC. be and the same are hereby amended as follows:

Article I is hereby amended to read in its entirety as follows:

ARTICLE I

That the name of this corporation shall be "AMERICAN FESTIVAL BALLET, INC."

BE IT FURTHER RESOLVED, That the corporate officers execute Articles of Amendment to Articles of Incorporation and duly file said Articles of Amendment with the Secretary of State of the State of Idaho and any other governmental agency that is required."
