And we hereby certify -

First

That the name of said corporation is
"The Hood River Telegraph and Telephone
Company"

Second

That the purposes for which it is formed,
are to carry on the business of Telegraphing
and Telephoning between the Towns of
Bellvue, Hailey, Bullion, Ketchum, Galena,
Vienna, Sawtooth City, and such other
Towns along Hood River in Alturas County
Territory of Idaho that the company
may deem proper to connect with, and in
Idaho and all of said Towns.

Third

That the place where its principal
business is to be transacted, shall be
the Town of Hailey in Alturas County
aforesaid.

Fourth

That the term for which it is to exist
is Fifty years from and after the date of
its incorporation.

Fifth.

That the number of its Trustees. at the date of its incorporation shall be Seven, and that when the lines are extended, so as to include the towns of Galena and Saultoth City in said county, then at the option of the board of Trustees then existing, the number of Trustees may be increased to nine and that the names and Residences of those who are appointed for the first two years are-

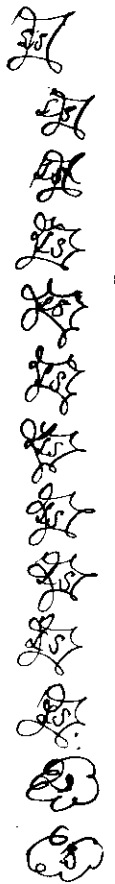
