## ARTICLES OF INCORPORATION

## COMMUNITY FIBER OPTIC NETWORK TRANSPORT SYSTEM, LTD.

The undersigned, in order to form a Non-Profit Corporation under the provisions of Litle 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

Article 1: The name of the corporation shall be Community Fiber Optic Network Transport System, Ltd.

Article 2: The purpose for which the corporation is organized is:

- (a) To provide a community fiber optic network transport system;
- (b) To satisfy charitable, religious, educational, or scientific within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 as amended from time to time, including, for such purposes, the making of distributions to organizations that qualify as exempt under Section 501(c)(3); and
- (c) To exercise all powers granted by law necessary and proper to carry out the foregoing purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or any other things of value. Nothing herein contained shall be deemed to authorize or permit the corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under this Act, or any amendment thereto or substitute therefor, may not at any time lawfully carry on or do.
- (d) Limitations: No part of the net earnings or the assets of the corporation shall inure to the benefit of, or be distributable, to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions and furtherance of the purposes set forth in Article 2 above. No substantial part of the activities of the corporation shall be for the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation, exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time.

Article of Incorporation - 1
