CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF NORTHERN LIGHTS, INC.

We, Gordon J. Hudson and Donald L. Gillingham, being the President and Secretary-Treasurer, respectively, of Northern Lights, Inc., a corporation organized and existing under the laws of the State of Idaho, do hereby certify that a regular meeting of the members of said corporation was held at the Bonner County Fairgrounds on the 13th day of May, 1989. Said meeting was held in accordance with the laws of the State of Idaho; pursuant to written notice of the time, place and purpose of the meeting. At all times the members present and voting throughout constituted more voting power than required by the Articles of Incorporation of Northern Lights, Inc.

At said meeting Resolutions as hereinafter set forth were regularly proposed, voted upon and adopted by the vote of the membership.

- 1. Resolved that Article II, section (f) is hereby amended:
- (f) To engage in the business of providing telecommunications, satellite telecommunication reception and

related services; to own, sell, distribute, finance, lease, service, install, maintain and create such materials, equipment, properties and programs as may be required therefor and to do all and everything necessary, suitable, or proper for the accomplishment of this purpose either alone or through a subsidiary or in conjunction with other firms, or individuals, and either as principals of agents; provided that no telecommunications activity be taken which would jeopardize the Corporation's tax-exempt status; and provided further that telecommunications and related services may be provided to persons not members of the Corporation only if provision of said services will benefit the Corporation or its members, or enhance the Corporation's ability to provide said services to its members.

And further resolved and former section (f) be relettered as section (g).
