That a special meeting of the stockholders of the Sunshine Metals Corporation was duly and legally called and held at the office of the corporation at 720 Peyton Building, Spokane, Washington, on the 6th day of September 1961, at the hour of two o'clock P.M., and the following is a true and correct comy of the Resolutions of the stockholders, amending Article T and \overline{VIII} , voted and adopted by more than 2/3 of the shareholders of said corporation entitled to vote at said meeting.

ARTICL T

That the Articles of Incorporation be amended by changing the name of the corporation to Commonwealth Silver Inc., by which name it shall hereafter be known.

ARTICLE VIII

That the amount of capital stock of said cornoration shall be \$2,500,000.00 divided into 25,000,000 shares of the par value of 10g per share, all shares being NON-ASSESSABLE with equal voting rights.
