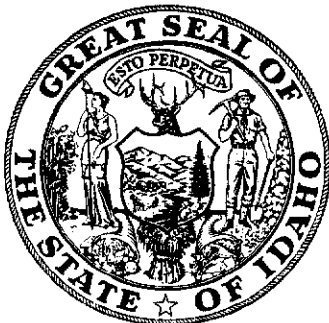

Article I.

The name of this corporation is PineRidge Software, Inc.

Article II.

The duration of this corporation shall be perpetual.

Article III.

The purposes of this corporation are as follows:

- a. To engage in and carry out the general business of development, manufacture, purchase, marketing and sale of computer software, hardware and related systems and components to include, but not be limited to, the following:
 - 1) The development, ownership, licensing and sale of original computer software.
 - 2) The provision of consulting services that may include development, maintenance, sales and marketing of computer software, computer hardware, information services, internet services and data processing systems.
 - 3) The provision of marketing and consultation services to manufacturers, developers, designers, wholesalers, service providers and retailers.

- d. To transact any and all lawful business for which corporations may be incorporated under the general business corporation act and other applicable laws of the State of Idaho.
