# ARTICLES OF INCORPORATION OF PAYETTE SPORTS BOOSTER, INC. A NON-PROFIT CORPORATION

### KNOWN ALL MEN BY THESE PRESENTS:

We the undersigned, citizens and residents of the State of Idaho and the United States of America, over the age of twenty-one (21), for the purpose of organizing and forming a non-profit corporation under the provisions of the Idaho Non-Profit Corporation Act (Title 30, Chapter 3, Idaho Code, Sections 30-301 to 30-332) and all other pertinent laws of the State of Idaho, do hereby associate ourselves and adopt the following Articles of Incorporation:

#### ARTICLE I

The name of this corporation is the Payette Sports Booster, Inc., and its duration shall be perpetual.

#### ARTICLE II

The purpose of this corporation is to promote athletic functions at the Payette Schools and to assist other worthwhile clubs and organizations.

This corporation is organized exclusively to support educational purposes within the meaning of section 501(C)(3) of the Internal Revenue Code.

Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(C)(3) of the Internal Revenue Code.

Articles of Incorporation - Non-Profit - 1

This organization is not organized for profit, and no part of the next earnings shall inure to the benefit of any private shareholder.

#### ARTICLE III

The corporation is to have one class of members, which shall consist of any interested person who has paid the \$1.00 annual membership fee set by the board of directors.

#### ARTICLE IV

The street address of the intitial registered office of the corporation is: 712 6th Avenue North, Payette, Idaho.

The name of the corporation's intitial registered agent at this address is: JERRY ALLEN.

#### ARTICLE V

The number of directors constituting the intitial Board of Directors shall be five. However, the Board of Directors may allow any and all persons or committees of such persons as they desire to attend meetings and otherwise assist in the management of the corporation.

#### ARTICLE VI

- The management of the affairs and business of the coporation shall be vested in the Board of Directors.
- 2. The number, qualifications, powers, duties, terms of office, manner of election, and times and places for meetings of the Board of Directors shall be prescribed by the Board of Directors and recorded in the By-Laws of the corporation.
  - 3. The members may adopt By-Laws by a majority vote which

will further the purposes of the corporation as established in Article II.

- 4. The officers of the corporation shall be designated, named, elected or appointed in a manner to be prescribed in the By-Laws of the corporation.
- 5. Amendment to these Articles shall be made by adoption of such amendment at a meeting of the members by the vote of a majority of the members.

#### ARTICLE VII

The assets of this corporation on dissolution or final liquidation shall be distributed to an organization which has established its tax exempt status under Section 501(C)(3) of the Internal Revenue Code.
