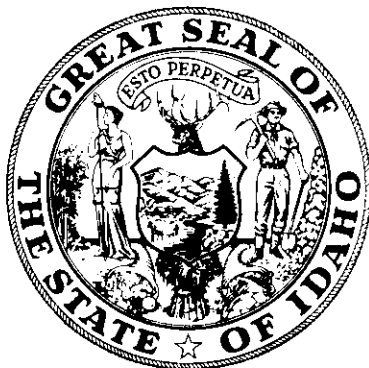

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is ETHANOL MARKETING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares with a par value of \$2.50 per share for a total authorized capital stock of Twenty Five Thousand and 00/100 Dollars (\$25,000.00), all of which shall be nonassessable, common stock with equal voting and other rights and privileges.

FIFTH: Provisions denying preemptive rights are: None.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: None.

SEVENTH: The address of the initial registered office of the corporation is ~~1000 Main~~ 4948 Kootenai, Boise, Idaho 83707 and the name of its initial registered agent at such address is James T. Glancey.
