ARTICLES OF INCORPORATION

IDAMO COUNTY CATTLEMEN'S ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, citizens of the United States and residents of the State of Idaho, do hereby associate ourselves together to form a non-profit corporation in order to form a corporation for the purposes hereinafter stated under and pursuant to the provisions of Chapter 10, Title 30, Idaho Code and the laws of the State of Idaho relating to the organization of corporations where pecuniary profit is not the object, do hereby certify and declare as follows:

Ι

The name of this corporation is "Idaho County Cattlemen's Association, Inc."

Ιī

The purpose and objects for which this corporation is formed are without pecuniary profit to promote and protect the business of raising cattle through cooperation with law enforcement, Indian Service, Forest Service, Wildlife, Soil Conservation and Education Agencies; to promote good, sound constructive range and pasture management; to promote cattle exhibitions, shows, and sales; and to promote, conduct and provide for and carry on any and all activities and do all things necessary to further the interests of the members of said association and for the said purposes; and to that end to buy, sell, hold, acquire, own, mortgage, hypothescate, transfer, lease, exchange, trade or otherwise acquire or dispose of real and personal property; and otherwise do all acts and things necessary or convenient in or about the conduct, management and carrying on of such objects and purposes; and to make, perform and carry out contracts and agreements for any lawful purposes to the same extent as fully as natural persons might or could do; and to do, perform and carry on the

business as principal agent, trustee and otherwise and either or alone or in conjunction with any other person, firm, association or corporation and with agencies, departments and officers of the State and Federal Government.

III

This corporation shall have perpetual existence.

IV

The location and post office address of the registered office of the corporation is Grangeville, Idaho County, State of Idaho.

V

This corporation is not organized for pecuniary profit and it shall not have or issue any capital stock. Membership in the corporation shall be limited to producers of beef type cattle, whether an individual, partnership, corporation or association. The rights and interests of all members are equal.

VΙ
