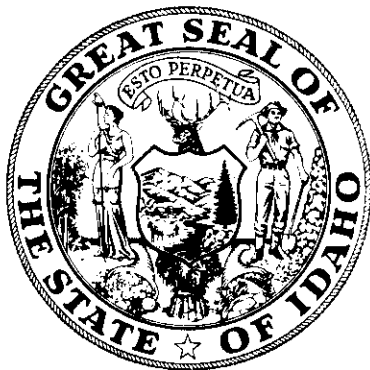

ARTICLES OF AMENDMENT 100 JUN 9 AM 8 52  
to the  
ARTICLES OF INCORPORATION  
of  
LAVIGUER MAHER DISTRIBUTING, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Laviguer Maher Distributing, Inc. has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is Laviguer Maher Distributing, Inc.

II

The following amendment of the Articles of Incorporation was adopted by the board of directors of the corporation on May 21, 1980, in the manner prescribed by the Idaho Business Corporation Act:
