ARTICLES OF INCORPORATION

of

LION REGIMENT, THE PRIDE OF IDAH A 42 PM 80

A Nonprofit Corporation SECRETARY OF STATE

WE, THE UNDERSIGNED, all residents of the State of Idaho, and citizens of the United States, being the age of majority, have for the purpose of forming a nonprofit association, pursuant to "the Idaho Nonprofit Corporation Act," Chapter 3, Title 30, Idaho Code, adopted the following articles of incorporation.

ARTICLE I

NAME: The name of the corporation shall be LION REGIMENT, THE PRIDE OF IDAHO, Ltd.

ARTICLE II

<u>LOCATION</u>: The principal office of the corporation shall be located in the city of Boise in the County of Ada.

ARTICLE III

NONPROFIT STATEMENT: The corporation is organized and operated as a nonprofit corporation in compliance with Chapter 3, Title 30, Idaho Code.

ARTICLE IV

<u>DURATION</u>: The period of the duration of the corporation is perpetual.

ARTICLE V

<u>PURPOSE</u>: The mission of the Lion Regiment is to provide an encouraging social environment primarily for men with interests in Leather, Levi, and Uniforms. This is to be done by providing an organization primarily of and for such men and promoting those events which feature such. The corporation is organized exclusively for social and fraternal purposes within the meaning of Section 501 (c) (7) of the Internal Revenue Code.

ARTICLE VI

POWERS: The corporation shall have all the power granted nonprofit corporations under the laws of the State of Idaho. Notwithstanding any other provision of these articles, however, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (7) of the Internal Revenue Code.

ARTICLE VII

<u>FUNDS</u>: No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for the sevices rendered and to make payments and distributions in futherance of the purposes set forth in Article V, above.

ARTICLE VIII

DISTRIBUTION AND DISSOLUTION: Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code, giving strong preference to donations to a 501 (c) (3) corporation with charitable purposes.

ARTICLE IX

<u>ADDRESS</u>: The name of the initial registered agent and his address which will also be the initial registered office of the corporation is: Don Carroll, 1912 N. Phillippi, Boise, Idaho, 83706.

ARTICLE X

INITIAL DIRECTORS: The four persons listed below shall constitute the initial Board of Directors who shall serve until the first meeting of the corporation called by the Board or until their successors are elected and qualified.
