And we hereby certify that the objects for which this corporation is formed are to establish a Bethel African Wethodist Episcopal Church in Boise City, Ada County, Idaho, for the purpose of public worship and religious training in said Boise City and vicinity and to acquire and hold both real and personal property for the purposes and to the extent of carrying out the objects of said corporation.

III

That the principal place of business of this corporation shall be in Boise City, Ada County, Idaho.

That the term for which this corporation is established shall be fifty years from and after the date of incorporation.

That the title of the persons making these Articles of Incorporation are trustees, of whom there shall be nine, to be elected annually, as provided for in the discipline of said church.
