### CERTIFICATE OF INCORPORATION

I, JAS H. YOUNG, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

#### BIBLE BAPTIST CHURCH OF HOMEDALE, IDAHO, INC.

was filed in the office of the Secretary of State on the **5th** day of **December** A. D. One Thousand Nine Hundred **Fifty-seven** and is duly recorded on Film No. **101** of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for **perpetual existence** from the date hereof, with its registered office in this State located at **Homedale** in the County of **Owyhee** and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

A R T I C L E S   O F   I N C O R P O R A T I O N  
OF THE  
BIBLE BAPTIST CHURCH  
of HOMEDALE, IDAHO

Whereas, at a duly noticed and called meeting of the members of the BIBLE BAPTIST CHURCH congregation of Homedale, Idaho, held at the hour of 8:00 P.M. on the 13th day of November 1957, at the Homedale Bible Baptist Church, at which meeting there was present and voting 16 members of said body, a resolution was duly made, seconded and adopted by unanimous vote that they incorporate, and authorizing and directing the undersigned trustees, the signatures of whom are hereto attached, to execute and file Articles of Incorporation, incorporating said body and establishing an INDEPENDENT BAPTIST CHURCH.

NOW THEREFORE, We the undersigned, Dorsey Simpson, Walter Clarida, and Phil Parker being the designated and authorized persons, do hereby execute and acknowledge Articles of Incorporation of the BIBLE BAPTIST CHURCH of HOMEDALE, IDAHO, as follows:

ARTICLE I

The name of said Corporation shall be the BIBLE BAPTIST CHURCH of Homedale, Idaho, Inc.

ARTICLE II

The objects, business and purpose of said corporation shall be in accordance with the principal beliefs and practices of Independent Baptists, namely:

In common with Baptists of all ages and nations, we believe in the plenary and verbal inspiration and authority of the Scriptures; in the pre-existence, the incarnation through His virgin birth, and essential deity of our Lord Jesus Christ; in His substitutionary and atoneing death, providing redemption through His shed blood; in His bodily resurrection; in His ascension and exaltation into Heaven;

His present mediatorial high priestly office; in the gift of and the person and work of the Holy Spirit; and in our Lord's personal, visible return, and His ultimate kingdom and reign, We therefore repose our faith in the Lord Jesus Christ for salvation, believing in the teaching and practices for which they have ever stood, namely:

1. The Lordship of Jesus Christ;
2. The Bible, the standard of faith and practice;
3. Regenerated membership;
4. Believers immersion;
5. Progressive Sanctification;
6. Full liberty;
7. Congregation government;
8. Separation of church and state;

to provide for the worship of God, the teaching and preaching of the Word of God, the winning of people to a personal faith in the Lord Jesus Christ, and in the spiritual improvement of its members, to administer the ordinances of the New Testament, and to advance the interests of the above name Church in the community of Homedale, Idaho, and to extend the ministry of the Gospel unto all the earth, and to that end the corporation shall have the power and authority to acquire, hold, rent and dispose of real, personal and mixed property by gift, donation, devise and purchase and in accordance with the rules and by-laws, to sell, dispose of, convey, lease or mortgage any such property; and the said corporation shall have power and authority to borrow money to further its objects and shall have power generally to do and perform each and every act and thing necessary, proper and convenient to carry out the objects and purposes for which it is organized, or any of the objects herein granted, or are or will be granted to such corporation by the laws of Idaho.

### ARTICLE III

The duration of the corporation shall be perpetual.

### ARTICLE IV

This corporation shall be located in Owyhee County, and the post office address shall be Homedale, Idaho.

### ARTICLE V

The name and post office addresses of each of the incorporators, all of whom are of full-age and citizens of the United States, / of this non profit and no stock corporation are as follows:

The governing body which is to exercise the powers of said corporation shall be the congregation of active members of said Bible Baptist Church, An active member is one who has personally believed on the Lord Jesus Christ as Saviour; received believer's baptism (by immersion in water); is joyfully in accord with the statement of faith and principles of this church and willingly enters covenant relationship with the other members of this church in perpetuating, supporting and propagating the Gospel and the ministry of the ordinances of baptism and the Lord's Supper. No person shall be elected to office in this church or as trustee of this corporation who has not signed a statement of belief and acceptance of the faith and practices as set forth herein. Trustees are the legal agents of this corporation and as such shall manage the properties of said body according to the Constitution and By Laws. The Annual Meeting of this body shall be held on the third Wednesday night of December of each year, and the clerk of the church shall file an ANNUAL STATEMENT of the officers elected in said meeting with the Secretary of the State of Idaho..
