ARTICLES OF INCORPORATION

OF

BLAINE COUNTY HUNGER COALITION, INC.

To the Secretary of the State of Idaho: The undersigned, in order to form a Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following Articles of Incorporation to the Secretary of State.

ARTICLE I.

Name.

Idaho Code Section 30-3-27

The name of this Corporation shall be BLAINE COUNTY HUNGER COALITION, INC.

ARTICLE II.

Purpose.

- A. The organization is organized exclusively for charitable, religious, educational and/or scientific purposes under section 501(c)(3) of the Internal Revenue Code.
- B. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue code, or corresponding section of any future federal tax code.

ARTICLE III.

By unanimous consent of all, Tom Iselin presided as chairman and secretary of the meeting.
The chairman noted that each director waived notice of the meeting by attendance at the meeting, and did not object to holding the meeting or transacting business at the meeting. The chairman announced that notice of the meeting having been waived and a quorum of directors being present, the meeting was now regularly and lawfully convened.
