ARTICLES OF INCORPORATION

WE, the undersigned, being three or more natural persons of full age, at least two-thirds of whom are citizens of the United States or its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the state of Idaho and to that end hereby adopt Articles of Incorporation as follows:

T

That the name of the corporation is AMERICAN COMMUNICATIONS INC.

II

That the purpose for which said corporation is formed is to operate a radio repair and replacement business including sales and service of radio equipment and allied lines and also to engage in the management of business corporations, associations, partnerships, entities, proprietorships, and other organizations of every kind; to purchase, or otherwise acquire, own, hold, lease sell, exchange, assign, transfer, mortgage, pledge or otherwise dispose of, to guarantee and to invest, trade and deal in and with personal property of every class and description; to purchase or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage, or otherwise dispose of, and to invest, trade and deal in and with real property, and any and all interest therein; to enter into any kind of contact or agreement, cooperative or profit sharing plan or pension trust with its officers or employees that the corporation may deem advantageous or expedient or otherwise to reward or pay such persons for their services as the directors deem fit; to purchase, lease, or to otherwise acquire, in whole or in part, the business, good will, rights, franchises and property of every kind, and to undertake the whole or any part of the assets or liabilities of any person, firm, association

or corporation engaged in or authorized to conduct any business similar to any business authorized to be conducted by this corporation, or contact property necessary or suitable for its purposes, and to pay for the same in cash, in the stock or bonds of this company, or otherwise to hold or any manner dispose of the whole or any part of the business or property so acquired and to exercise all the powers necessary or incidental to the conduct of such business.

To lend money and to negotiate and make loans, either on its own account or as agent or broker for others; to borrow money, to issue bonds, debentures, notes and other obligations of this corporation from time to time for any of the objects or purposes of this corporation from time to time for any of the objects or purposes of this corporation and to mortgage, pledge, hypothecate, and/or convey in trust, any or all of its property to secure the payment thereof, to discount and negotiate promissory notes, drafts, bills of exchange, and other evidences of debt, and to collect for other money due them on notes, checks, drafts, bills of exchange, commercial paper and other evidences of indebtedness; to enter into, make and perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state, or government, or any subdivisions, district or department thereof; to acquire and pay for in cash, shares of stock, bonds or notes of this corporation or otherwise, the assets including the good will of any person, firm, association or corporation, and to undertake or assume the whole or any part of the obligations, or liabilities thereof; to engage in and conduct any and all kind of radio business; to do any and all such other acts, things, business or business in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects herein before enumerated, or calculated, directly or indirectly, to promote the interest of the corporation; and in

carrying on its purposes, or for the purpose of attaining or furthering any of its business, to do any and all acts and things, and to exercise any and all powers, now or hereafter may be authorized in this statement of purpose shall be construed, as both purposes and powers, and the statements contained in each clause shall be in nowise limited or restricted, by reference to, or inference from the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

III

That the termsof the corporation is perpetual.

IV

That the principal office and place of business of said corporation Star Route, Box 27, City of Pocatello, County of Bannock, State of Idaho.

V

That the number of directors of said corporation shall be not less than two nor more than seven, as determined by the stockholders or directors of said corporation from time to time.

VI

That the amount of total authorized capital stock of this corporation is \$5,000.00 consisting of fifty (50) shares of capital stock of the par value of \$100.00 per share, and the entire voting stock of this corporation shall be divided into said fifty shares of common stock.

VII

That the amount of capital stock of said corporation which has actually been subscribed is 3 shares of capital stock.
