MONOW ALL MEN BY THESE PRISENTS, That we, the undersigned, in order to form a corporation for the purposes hereinafter stated pursuant to the Business Corporation Act of Idako, do hereby certify as follows:

### ARTICL: I

The name of the corporation is Buyers Enterprises, Inc.

### ARTICL: II

The corporation is to have perpetual existence.

## ARTICLE III

The location and post office address of the registered office of the corporation is 6916 Folk Street, Boise, Ada County, Idaho.

#### ARTICLE IV

The corporation is authorized to issue one class of share of capital stock to be designated as common stock.

The total number of par value shares authorized is 400 shares of the par value of \$25.00 per share. The aggregate par value of said authorized shares of common stock is \$10,000.00.

### ARTICL Y

The purposes for which said corporation is formed are:

- (a) To carry on a general investment business including the purchase, sale and improvement of all items of commerce not prohibited by law and to handle, deal in and with such items including buying, selling and generally dealing in all supplies and parts in connection therewith.
