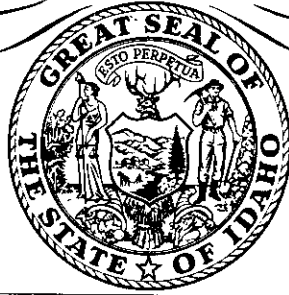

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Twentieth** day of **January** 19 **64**, original articles of amendment, as provided by Sections **30-146, 30-147 and 30-148, Idaho Code, increasing the authorized capital stock to \$50,000.00 divided into 50,000 shares at the par value of \$1.00 each,**

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No. **126** of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

These Articles of Amendment and the following certificate is hereby made and executed pursuant to Section 30-146, Idaho Code, for the purpose of amending the Articles of Incorporation of Payette-Bonanza Mining Co., Inc., an Idaho corporation, and to thereby increase the authorized capital stock of said corporation from the amount of \$32,000.00 to the amount of \$50,000.00.

The undersigned, Denver Large, President of said corporation, and ~~Adolph XXX Becker~~ ^{William Hollinger}, Secretary of said corporation, do hereby respectively certify as follows:

I

That a meeting of all of the stockholders and directors of Payette-Bonanza Mining Co., Inc., an Idaho corporation, was held on December 27, 1963, at Garden Valley, Idaho, pursuant to call and waiver of notice signed by all of the stockholders and directors and filed in the minute book of the corporation.

II

That at such meeting, the following resolution was presented and upon motion duly made, seconded and unanimously carried, the same was adopted:

"WHEREAS, It is deemed to be in the best interests of the corporation that the authorized capital stock of said corporation be increased from \$32,000.00 to \$50,000.00;

"BE IT RESOLVED, That Article V of the Articles of Incorporation of Payette-Bonanza Mining Co., Inc., be amended by deleting the entire said Article V, and inserting in place thereof the following:

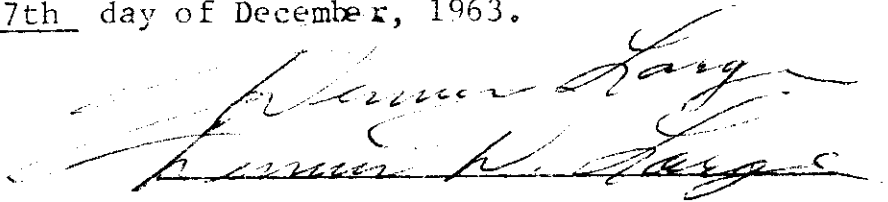
'ARTICLE V

'The authorized capital stock of this corporation shall be \$50,000.00, divided into 50,000 shares, each share having a par value of \$1.00. No distinction shall exist between the shares of this corporation, and all such shares shall have the same rights in the corporation. No shares of the capital stock shall be issued until fully paid for'."

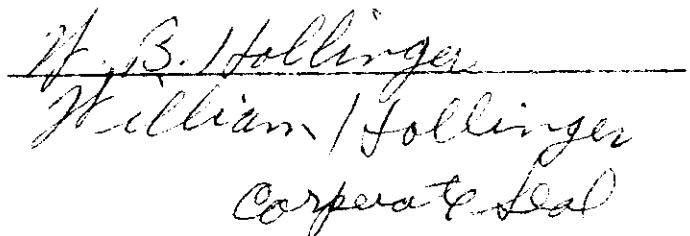
